The FONDATION D'ENTREPRISE HERMES has created this privacy and personal data protection policy ("Privacy Policy") in order to communicate the FONDATION D'ENTREPRISE HERMES 's policies and practices relating to the collection, use and disclosure of information about you obtained on the www.fondationentreprisehermes.org website.

What information is collected on fondationentreprisehermes.org?

You may use the fondationentreprisehermes.org website without providing any personal information to the FONDATION D'ENTREPRISE HERMES. You will however, need to provide certain information, including your name, address, telephone number and e-mail address if you choose to receive information from the FONDATION D'ENTREPRISE HERMES.

Any information you provide on the fondationentreprisehermes.org website will be stored on the FONDATION D'ENTREPRISE HERMES's server in France.

Your personal information are kept 10 years.

You may also request by sending an e-mail to the FONDATION D'ENTREPRISE HERMES to delete your personal information at any time as soon as your request to the FONDATION D'ENTREPRISE HERMES has been processed and delivered (see "Changes and access to your personal information"). The FONDATION D'ENTREPRISE HERMES may collect non-personal information about you (see "Cookies").

What use is made of the information you provide on fondationentreprisehermes.org?

The FONDATION D'ENTREPRISE HERMES may disclose the information you provide on the fondationentreprisehermes.org website to third parties who provide services on or to the fondationentreprisehermes.org website. The FONDATION D'ENTREPRISE HERMES may disclose your information if we believe in good faith that such disclosure is necessary to comply with applicable law, a subpoena or other legal process.

For example, the FONDATION D'ENTREPRISE HERMES may disclose such information as is necessary to identify, contact or bring legal action against a person or entity who may be violating the fondationentreprisehermes.org Terms and Conditions, or who may be causing injury to, or interfering with, other users of the fondationentreprisehermes.org website.

Cookies
